**PRIVACY DISCLAIMER PURSUANT TO ART. 13 EU Regulation 2016/679**

In accordance with the provisions of EU Regulation 2016/679 concerning the protection of natural persons with regard to the processing of personal data, Soroptimist International of Italy, in the person of its pro tempore legal representative and the Soroptimist International of Europe, in the person of its pro tempore legal representative, in the capacity of joint controllers of the processing of your personal data, inform you of the following.

#### **1. Data controllers**

The data controllers are, each for their own competence: Soroptimist International of Italy, in the person of the pro tempore President, with domicile at the Permanent Secretariat, in Milan, Via Cernuschi, 4, email [sep@soroptimist.it](mailto:sep@soroptimist.it) and Soroptimist International of Europe, in Geneva, Route de Florissant 72 - 1206 GENEVA, email [SIEHQ@soroptimisteurope.org](mailto:SIEHQ@soroptimisteurope.org)

#### **2. Purpose of the Processing**

Your personal data will be processed for the following purposes:

- a) obligations related to the Call for applications for the admission of young graduates to the "Leadership without borders" training course, created in agreement with the SDA BOCCONI of Milan;
- b) Sending communications by email or mobile phone necessary for the achievement of the purposes referred to in letter a);
- c) Purposes connected or instrumental to the fulfillment of obligations established by the Statutes and Regulations of the Federation, Union and Club, laws, regulations, community regulations or by provisions issued by Authorities;
- d) sending via e-mail and/or ordinary mail illustrative material concerning the activity of the Federation, Union and of the individual Clubs, including invitations to meetings and/or conventions and/or conferences in person or remotely, organized by the association itself.

#### **3. Legal basis of the treatment**

Processing for the purposes referred to in letters a) and b) referred to in point 2 is based on your consent and is mandatory as it is necessary for the management of your application. In the event of failure to provide consent, we will not be able to process your selection request. The treatment referred to in letter c) of point 2 is based on the need to fulfill legal obligations to which the owners are subject. The treatment referred to in letters d) of point 2 is based on your consent.

#### **4. Categories of recipients**

Your data, for the exercise of the purposes referred to in point 2, could be communicated to other Members

or to personnel authorized by the Federation, Union and Club to carry out the selection operations in the capacity of members of the Evaluation Commission, to consultants who take care of the statutory obligations and tax regulations of the Club, the Union and the Federation, and in general to expressly instructed and authorized subjects, or to external managers expressly designated with deeds which provide for all the requisites referred to in Article 28 of the Regulations; The data of the selected candidate will also be communicated to SDA Bocconi for the completion of enrollment in the training course;

#### 5. Storage period

Your personal data will be kept by the Data Controllers, exclusively for the time necessary to achieve the purposes referred to in point 2., or until the express revocation referred to in point 8 below. Your personal data will be kept for the time necessary to carry out the selection operations for participation in the competition referred to and to allow the sending via e-mail and/or ordinary mail of illustrative material concerning the activity of the Federation, Union and of the individual Clubs, including invitations to meetings and/or conventions and/or conferences in presence or remotely, organized by the Soroptimist International Association of Europe and Soroptimist International of Italy, for the time foreseen by the relevant reference standards and by virtue of your given consent.

Rights of the interested party as an interested party,

You have the right to ask the data controllers for access to personal data, rectification or cancellation of the same or limitation of treatment or to oppose the treatment in the cases provided for. You also have the right to request the portability of your data.

#### 6. Withdrawal of consent

In cases in which the treatment is based on consent (purpose referred to in point 2 letters a) and b)) you can revoke the consent given at any time without this affecting the lawfulness of the treatment carried out before the revocation. In the event of withdrawal of consent, the processing will no longer be permitted and the withdrawal therefore makes it impossible to proceed with the examination of your application.

#### 7. Right to complain

In the event of incorrect processing of your personal data, you can lodge a complaint with a supervisory authority or in any case with the Ordinary Judicial Authority.

#### 8. Mandatory consent

Consent for the purposes referred to in letters a), b) and c) is mandatory in order to process your application and proceed with the selection operations. In case of refusal to give the necessary consent, your application cannot be taken into consideration.
